

Internet Sales Policy

All wholesale accounts selling Studio M products on the Internet must either have a successful brick and mortar storefront carrying the same type of product as posted on their website or an online store with its own shopping cart, check out process, and unique URL that represents appropriate categories.

- Internet-only websites must be full-time operations with professionally-designed site graphics and user interface, and must be regularly updated or freshened.
- All third-party online marketplaces such as Amazon.com, Walmart.com, Sears.com, etc. are prohibited. We are not interested in opening accounts who use these types of platforms.
- eBay, Yahoo!, Auction sites, Boomerang or other internet stores of similar nature are also not eligible for consideration.

Minimum Advertised Price (MAP) Policy

Competitive pricing pressures have led to aggressive discounting that threatens to damage the value of Studio M and our products. As of July 1, 2017 we implemented a minimum advertised price (MAP) policy to help protect Studio M and our retailer partners. This policy defines the minimum price you may advertise our products, but in no way restricts you, as a retailer, from determining your final selling price. **Please visit studio-m.com/MAP to review the specifics of our MAP Policy.**

Terms of shipments

- Orders are generally shipped within three days from receipt of order unless POD which ship in five business days.
- Retailers must carry in inventory a fair representation of all items listed on their websites with the exception of Drop Ship items.
- Internet returns are handled by the seller. Seller should contact Studio M on Drop Shipment returns due to defective product as return authorization is required.
- All Studio M products and/or product names must be identified as Studio M and accompanied by proper identification of the products as “MailWraps® Magnetic Mailbox Covers”, “Yard DeSigns® Magnetic Yard Art”, “BreezeArt® Premium Decorative Flags”, or “MatMates™ Interchangeable Doormats”. All uses of the trademarks “MailWraps”, “Yard DeSigns”, or “BreezeArt” must be accompanied by the ® registered trademark designation. All uses of the trademark “MatMates”, “Art Poles”, “Art Pots”, “Art Planters”, “Gypsy Garden”, “Art Planks”, “Art Pavers”, “Merriment”, “Kaleidoscope”, “Wings of Whimsy”, “Houseplants” and “Door Décor” must be accompanied by the ™ trademark designation.

These trademarks and words may not be used in any way except to sell the respective products manufactured by Studio M. Any uncorrected misuse of these images may result in termination of the undersigned retailer's status as an authorized Studio M retailer and/or legal action.
